Payroll / finance records	Invoicing, payments, HMRC reporting	Legal obligation – compliance with tax and employment laws.
Website / technical data (IP, cookies)	Operating and improving our website	Legitimate interests – ensuring site functionality and analytics (subject to cookie consent)

## 5. Data sharing and transfers

We may share data with:

- Clients seeking candidates.
- Payroll and compliance providers.
- Cloud-based CRM and email systems hosted in the UK or EEA.

We never sell personal data.

#### 5.1 International Transfers

Some of our technology providers may store or process data outside the United Kingdom or European Economic Area (EEA), for example cloud platforms such as Microsoft, Google, or LinkedIn.

When this happens, we ensure that adequate safeguards are in place to protect your personal data, including:
